Street, Sidewalks and Storm Sewers-Northwest Consultants is continuing to work on the grant for the Ohio Public Works Grant is due September 4th. The Administrator

met with RA Bores on a preconstruction budget amount and has also met with the landowner for obtaining an easement for the proposed new storm line.

The Village recently applied for a \$1,000.00 recycling grant through Erie County Solid Waste management District.

The vacant lot at the intersection of Main and Merry Streets is scheduled to go up for bid soon.

Parks and Trees-Roe's Tree Service removed several dead trees throughout the Village.

Dayne Polta completed the prepping, priming and painting of 18 light posts around the square for his Eagle Scout project, and did a very nice job.

The 1995 Kodiak dump truck is out for sealed bid, and has been advertised. A minimum of \$3,000.00 will be accepted through August 26th, with the bid opening taking place on August 27th.

Part-timer Alex Stelzer's employment had ended due to his return to school, and Cody Ostheimer will now fill the part-time position.
