Village of Milan Council Meeting February 26, 2025

February 26, 2025, Council Meeting was called to order with the Pledge of Allegiance by Mayor Pam Crosby at 6:30 P.M.

CITIZEN PARTICIPATION

Kaitlyn Brulia from Edison Birthplace explained and requested to consider becoming an Official America 250-OH Community. The Council is ok with the Village Administrator completing the AM 250-OH application and a resolution will be present at the March Council meeting to form a committee.

Serving Our Seniors Director Sue Daugherty and Fundraising & Resource Coordinator Amy Bowman-Moore gave a progress report on their efforts to stimulate the construction of affordable housing for the benefit of older citizens. Sue explained that affordable housing continues to be a problem for our seniors. Serving Our Seniors has hired Amy Bowman-Moore to be their grant writer and assist with the affordable housing project. Amy explained that they have a builder that is currently willing to build 13 duplex housing (about 700 sq. ft. per unit) with a control rent program.

Bill Harris, Finance Officer of the American Legion requested donations for fallen Veterans flags at the Cemetery.

Streets, Sidewalks and Storm Sewers –ECS Midwest has provided us their report on Milan Manor Hillside for a Slope Failure Analysis which included two suggested options to make the necessary repairs. Huron County Engineer's Office and Richland Engineering are currently reviewing the two options.

NEW COMMITTEE BUSINESS

Streets, Sidewalks and Storm Sewers – The Street Department plowed/salted the roads on several occasions, performed truck maintenance on equipment, patched potholes, assisted the Electric Department on an outage and the Water Department with a water leak.

Bobby Cumston is enrolled in the ODOT Online Courses through their Local Technical Assistance Program. He has completed the following courses: Heavy Construction Equipment Program, Roadway Safety, and Project Management Training Program. The upcoming courses he will be taking include Pavement, Snow and Ice Management, Grant Writing, CDL Theory and Ohio Traffic Incident Management.

Safety – The AMP Safety Training for February was cancelled by the instructor.

The Electric, Street, and Water departments will be attending an AMP Safety Training on Live Line Equipment and Protective Cover Up.

Fire Safety Services completed our annual maintenance/inspections on all Village owned fire extinguishers.

Finance – Fiscal Officer Clapp stated the Village received \$11,641.05 in interest for January.

Fiscal Officer Clapp informed the Council about the upcoming State Auditor Local Government Officials Conference being held in Columbus, March 27-28th that is for Fiscal Officers, Council Members, Mayors and Village Administrators. The cost is \$250 plus hotel with a deadline to register for March 19th.

Fiscal Officer Clapp informed the Council she signed Amendment #1 to the State Auditor engagement letter for an increase cost of \$1,558 for the Year 2022 and 2023 State Audit which is a result from the complaints received from several Village residents.

Fiscal Officer Clapp informed the Council that the employees have completed FormFire for our upcoming health insurance renewal and a representative from USI insurance company is willing to come or zoom in during the March 20th Council Work Session.

Regional Planning, Building Code, and Inspection – The Design Review Board met and approved Great Lakes Electric's sign request for their N. Main Street location.

NEW COMMITTEE BUSINESS – cont.

Utilities – Water/Wastewater Department performed the following tasks: completed reports to the Ohio EPA, read meters where they found some high usage accounts, turned the water on at the old police station where a new business went in, assisted the Electric Department on several occasions and assisted the Street Department with snow removal.

Tim Heim attended and passed the Backflow Prevention Course.

We signed a contract with Buckeye Pump to rehabilitate the Indian Acres Subdivision Lift Station in the amount of \$32,803.23. This work will include removal of the existing piping, discharge elbows, guide rails and brackets in the wet well, installation of the new 4" ductile iron discharge connections, PVC fittings, and reinstall the pumps upon completion.

On February 12th, there was a water main break, south of Bond Street in which all departments assisted with this project, as well as having to call in R.A. Bores to assist.

The Electric Department read meters, assisted the Street Department with snowplowing, performed weekly substation and truck checks, removed the Christmas lights in the square and relamped four lights in the square, updated the cameras at the Administration and Police Station.

The power outage on February 13th was caused by an issue (the regulators or the underground primary wiring) with the South Substation and power was rerouted to the North Substation to cover the outage area. We had a subcontractor come in on February 21st to look at the substation regulators in which we are currently waiting for their report back.

On February 17th we had two electrical outages: a tractor trailer delivering salt to ODOT and forgot to lower his dump bed and hit the power line which caused a pole to break at the base. We invoiced the Company for the employees' hours worked and new equipment to complete the repair; a blown fuse on Broad Street near the elementary school which was caused by all the rain/snow and rapid freeze causing the fuse to corrode and short out.

Communications – Julie and Brian attended an Al Training at Erie County Community Foundation, that was put on by Lorain County Community College. This was an excellent training opportunity to learn more about this newer technology.

From our Trash Hauler Survey, we received 246 back: 82 residents would support a one hauler contract; 130 do not support this venture; and 28 would support it if it was cheaper.

Rospert reported to the Council she attended the Erie Counties Blue Ribbon Commission meetings in which discussion was held about how entities could join to share cost saving on health insurance for public employees and sharing large equipment. More meetings to come in reference to Fire Departments, Police Departments and Utilities.
